It is hereby informed that, Govt. in SD&TE Department vide their letter No. 4333 /SDTE dt. 12.11.2020 have approved for conduct of Ex-Regular 1st, 2nd, 3rd and 4th 2020 Summer Exams of Old course (2013-2017 Syllabus) in online mode in November 2020 and Examination of Ex-Regular students the 1st,2nd and 3rd semesters of New Syllabus(2018 Syllabus) of Summer 2020 Exams in online mode in December 2020.

- Ex-Regular Students of 2013-2017 syllabus, who have filled up form for 1st,2nd,3rd and 4th Semester Summer Exams 2020 as per procedure, are eligible to appear in the online Examination Summer 2020 of the respective semesters. Such students are required to make separate registration for above online exams in the online exams portal for the purpose.
- 2. The above Exams shall be tentatively held from 26/11/2020 to 30/11/2020 in 4 sittings in a day continuously (even on holidays), keeping in view the publication of Results in time, for enabling the students already secured Ranks on OJEE 2020 to participate in Admission process.
- 3. Such OJEE 2020 qualified candidates are to provide their OJEE 2020 information (OJEE Application Number) at the time of online Examination Registration.
- 4. In view of paucity of time, the Examination Registration portal shall be opened for only 2 days. The likely dates of Students Registration are 19th and 20th of November 2020. No request for extension of dates for Registration in the portal or for any activity shall be entertained.
- 5. The students shall be allowed to appear in the exams from the Exams centre in their own Institute. However, the students are at liberty to appear from home using Android based mobile phone through internet connection. Every Polytechnic shall be treated as Exams centre who are to provide computing infrastructure and reliable internet connectivity of appropriate speed and bandwidth for their own students.
- 6. It is being planned to conduct such examination through remote Proctored mode. For the purpose stable internet connection with minimum 512 Kbps speed internet connection is a prerequisite for appearing in the exams from a location.
- 7. The pattern of Exams shall be MCQ type and each sitting for a Theory subject shall be of 2 hours.
- 8. The Practical Examination shall be conducted in physical mode as usual.
- The students registration for online exams, exercise of choice of Exams centre shall be done in the SCTE&VT online Examination web portal in due course.
- 10. Other features of online Exams shall be same as 6th and 5th semester online Exams 2020.
- 11. Further details and examination schedule shall be intimated in due course.
- 12. Details of Activities of Online Examination of 1st, 2nd,3rd Semester Ex-Regular students of 2018 Syllabus shall be intimated in due course.

Principals of all Polytechnics are hereby requested to inform the students concerned accordingly and also advise the students to visit the website of SCTE&VT regularly to get the updates on the above semester online Exams 2020.
